**Terms and Conditions: The CSLB Norms Database**

These terms and conditions are the terms of agreement (the “Terms”) under which the University of Cambridge acting by and through its Centre for Speech, Language and the Brain, Department of Psychology, Downing Street, Cambridge CB2 3EB (the “CSLB”) agrees to let you (the “Authorised User”) access and use the CSLB Norms Database (“CSBL Norms”) upon your registration with the CSLB for this purpose.

By accessing and exercising any rights to the CSLB Norms, the Authorised User accepts and agrees to be bound by the Terms set out below:

1. The Authorised User agrees and acknowledges that the CSLB Norms is protected by copyright, database rights and other intellectual property rights and these Terms do not assign or transfer to the Authorised User or to any third party any right, title or interest therein except for the right to use the CSLB Norms in accordance with these Terms.
2. The CSLB hereby grants the Authorised User a world-wide, royalty-free, non-exclusive, non-transferable, revocable licence to:
  - 2.1 access and make a personal copy of the CSLB Norms for his or her private study and non-commercial research;
  - 2.2 access and use brief extracts or excerpts or portions of the CSLB Norms for display in teaching, application in non-commercial research and/or academic publication;
  - 2.3 access and modify or build upon the CSLB Norms to create a derivative work, including any data or material which is derived from the CSLB Norms or created by the combination or merger of the CSLB Norms in whole or in part with other data or material (“Derivative Work”), provided that any Derivative Work shall carry a declaration stating that the CSLB, those who carried out the original collection of data in the CSLB Norms and the funder/s or sponsor/s of the research bear no responsibility for the further analysis or interpretation of it by the Authorised User and others associated or affiliated with the Authorised User and the Derivative Work

***provided that*** for the above permitted uses and applications the Authorised User acknowledges and cites in any such display or research or publication in any format or media, the credit notice in the form specified on the CSLB Norms distribution notes or accompanying metadata or as otherwise prescribed by the CSLB. In the absence of such a notice, the credit line shall read:

To otherwise use the CSLB Norms, including making the CSLB Norms available in any manner in any media for use by any other person or organisation or to sell, assign, transfer, rent, lease, sublicense, lend, give or make available to others or otherwise transfer or dispose of the CSLB Norms in its present form or as converted or modified by the CSLB or the Authorised User is expressly prohibited, and requires the prior

written consent of the CSLB. For the avoidance of doubt, any use of the CSLB Norms other than as authorised under these Terms is prohibited.

3. Regardless of method of registration with CSLB to obtain access to the CSLB Norms, the Authorised User agrees not share his or her copy with other members of a research group s/he may be part of but encourage those members to individually register with the CSLB for access to the CSLB Norms.
4. The Authorised User agrees and acknowledges that the CSLB may hold and process any personal data submitted by the Authorised User for validation and statistical purposes and for the purposes of the administration and management of the CSLB Norms or for any other lawful purpose notified to the Authorised User by the CSLB and to which the Authorised User has consented under these Terms. For data storage purposes, the CSLB may store electronically the personal data collected for these purposes outside the European Economic Area (EEA). By submitting the personal data the Authorised User agrees to this transfer. The collected personal data is managed and stored by the University in accordance with the UK Data Protection Act 1998 <http://www.admin.cam.ac.uk/univ/information/dpa/>.
5. The Authorised User agrees and acknowledges that the personal data he or she submits to the CSLB is accurate to the best of his or her knowledge and that any changes in that personal data, including educational or employment status, will be made known to the CSLB at the earliest possible opportunity.
6. The Authorised User agrees that he or she shall retain full control over the use of the CSLB Norms and any modifications or enhancements thereof, and accordingly that the Authorised User shall be solely responsible for any use made of the CSLB Norms.
7. Neither the CSLB, nor the funders of the CSLB Norms nor the original data creators or depositors give any warranties or make any representations that the CSLB Norms or any Derivative Work will be suitable for any purposes, nor do they accept any responsibility for any limitations or errors in the CSLB Norms, nor do they accept any liability for any loss or damage whatsoever or howsoever caused arising directly or indirectly in connection with this Agreement, the CSLB Norms, its use or otherwise, except that which is unlawful to exclude. The CSLB expressly excludes liability for consequential or incidental loss or damage which may arise in respect of the CSLB Norms, its use, or for loss of profit, business revenue, loss of contracts, goodwill or anticipated savings. Notwithstanding the above, nothing herein shall be deemed to restrict or exclude any liability of the CSLB for death or personal injury to the extent only that the same arises as a result of the negligence of the CSLB, its employees, servants, agents or authorised representatives.
8. The Authorised User agrees to indemnify and shall keep indemnified the CSLB against any costs, actions, claims, demands, liabilities, expenses, damages or losses (including legal fees) arising from or in connection with any third party claim made against the CSLB or any of its employees or students relating to the Authorised User's use of the CSLB Norms or any other activities in relation to the CSLB Norms where such use is in breach of these Terms.
9. Any breach of any of the provisions of this Agreement will result in the immediate termination of the Authorised User's access to the CSLB Norms either permanently or temporarily at the discretion of the CSLB, and may result in legal action being taken against the Authorised User. If there is no breach of this Agreement, it may be terminated, or its terms altered, by the CSBL after thirty day's notice. Upon termination of this Agreement for any reason the Authorised User shall cease using the CSLB Norms and return all copies to the CSLB or destroy and delete all copies.
10. The failure by CSLB to exercise or delay in exercising a right or remedy provided by this Agreement or by law does not constitute a waiver of the right or remedy or a waiver of other rights or remedies.
11. The closure of the CSLB will not automatically terminate this Agreement. In that event custodianship of the CSLB Norms shall revert to the successor Department at the University.
12. The Authorised User is required to report promptly a breach of any of the Terms. Failure to disclose details of such a breach is a fundamental breach of this Agreement.

13. This Agreement represents the entire agreement between the CSLB and the Authorised User and supersedes all representations, agreements, statements and understandings made prior to the date of this Agreement.
14. The Authorised User shall not assign this Agreement or any interest therein without the prior written consent of the CSLB.
15. If any provision of this Agreement shall be held to be unlawful, invalid or unenforceable, in whole or in part, under any enactment or rule of law, such provision or part shall to that extent be severed from this Agreement and rendered ineffective as far as possible without modifying or affecting the legality, validity or enforceability of the remaining provisions of this Agreement which will remain in force and effect.
16. This Agreement (including without limitation non-contractual disputes or claims relating to this Agreement) shall be governed by and construed in accordance with English law and subject to the exclusive jurisdiction of the English courts.
